

VET caveats

General caveats

- The data provided in this section show the level and range of vocational education and training (VET) activity at an individual school. Care should be taken when comparing these data across schools, as schools often differ in the mix of courses and programs they provide to meet students' needs.
- Data reported by some jurisdictions may include international full fee-paying students resident in Australia.
- Australia's states and territories may have caveats relating to the data on this website. Further information should be sought from either the Australasian Curriculum, Assessment and Certification Authorities (ACACA), or from the school.
- Numbers of enrolments and numbers of qualifications should not be compared. Enrolments will include students in their first, second or third year of a VET course and from multiple cohorts, whereas qualifications completed are most likely to be issued in the final year of school. In addition, a student may intend to complete only a partial qualification or skill set while at school.

Qualifications completed	Standards Authority (NESA) for the recognition of VET in the Higher School Certificate or Record of School Achievement, and (b) data provided to NESA from TAFE NSW for submission to the national VET Providers collection. There is under-reporting of qualification enrolments from TAFE NSW
School-based apprenticeships and traineeships	School-based apprenticeship and traineeship (SBAT) data is reported to NESA by schools and TAFE NSW. There is under-reporting of SBATs from TAFE NSW

Qualifications completed	Not reported for Victoria. There are no data gathered from Victoria schools, which enables the reporting of VET Certificate completions within the Victorian Certificate of Education (VCE), VCE Vocational Major (VCE VM) or Victorian Pathways Certificate (VPC). The VCAA gathers data on VET units of competency completion and the contribution these units make towards the completion of the VCE, VCE VM or VPC. SbAT activity represents the completion or partial completion of a unit of competency by a student toward an Australian school-based apprenticeship or traineeship. The SbAT data were reported to the Queensland Curriculum and Assessment Authority by the Queensland Department of Education.

Some VET data may be reported incorrectly to the SACE Board resulting in under-reporting or over-reporting of VET data by certificate levels and/or Australian Standard Classification of Education (ASCED) codes.
Qualifications completed	Count of students who completed a VET qualification during their secondary schooling. The data provided are based on data from South Australian schools to the SACE Board for the recognition of VET in the SACE. Enrolments	The number of course enrolments where the student successfully completed at least one Unit of Competency (i.e., where the outcome identifier - national is 20, 30, 40 or 70) as part of a VET course in the reporting year. The data is provided by the Registered Training Organisations (RTO) conducting training for students in Northern Territory (NT) schools who are 13-19 years old as at 31 December of the reporting year.

	- A student can do more than one course in a year. Where a student is enrolled in more than one distinct qualification (i.e., where there are multiple program identifiers per client), these are counted as separate enrolments.
	- VET enrolments are counted for all NT school students aged 13-19 as at 31 December of the reporting year.
	- VET enrolments are counted against the school reported by the RTO delivering the training.
	- VET enrolments where school name was unknown, or homeschooling are excluded from this submission.
	- Only VET enrolments where AQF level was I, II, III or IV are included in this submission.
Qualifications completed	The number of VET course qualifications completed by school students in the reporting year (i.e., clients reported in nat130 file).
